IMPORTANT INSTRUCTIONS:

- The position is purely temporary and co-terminus with the project. The engagement shall be initially for a period of **ONE YEAR** or till the project duration, whichever is earlier. The engagement shall be extendable on yearly basis subject to performance review and project duration. The duration of the project is up to **28.02.2026**.
- The engagement of a project staff in different projects either in the CSIR – Indian Institute of Integrative Medicine, Jammu or different Lab./Instt. of CSIR taken together shall not exceed 6 years in any case. It would, therefore, not confer any right/claim, implicit or explicit, for any candidate for claiming extension or absorption in CSIR-IIIM, Jammu.
- Age will be reckoned as on the date of the Interview. Age relaxation for SC/ST/OBC/PWD candidates as per GOI/CSIR Instructions subject to production of certificates in prescribed format.
- Age relaxation for Widows, Divorced Women, and Women Judicially separated from Husbands who have not remarried since, as per GOI/ CSIR provisions.
- The filled-in Google Form should be submitted by or before **25th April 2025 (Friday) up to 05:00 PM**. Google/Application Forms submitted after the scheduled date and time shall not be entertained for the interview and summarily rejected.
- Only eligible candidates shall be accessed for the interview. The list of eligible candidates and the date for the interview will be displayed on the CSIR-IIIM Website, www.iiim.res.in, by the evening on **02nd May 2025 (Friday)**. Eligible/shortlisted candidates shall attend the interview on **MS Teams**. All shortlisted candidates will be required to send scanned copies of certificates (in a single PDF file), by 5:00 pm on **8th May 2024 (Thursday)**, through email to therapeutics2021@gmail.com.
- In case a large number of candidates apply, the Screening Committee may re-visit the screening criteria and shortlist the candidates for interview in proportion to the available vacancies.
- Candidate has the option to interact in English/Hindi before the Selection Committee.
- In case the final certificates reflect CGPA/SGPA/OGPA Grades, the candidate should convert the same into an equivalent percentage as per the approved formula of the University in the Google Form, and a copy of such conversion must be attached along with the Google form.
- To avoid any inconvenience, only those candidates who strictly fulfil the eligibility criteria and possess the degrees/mark sheets in the subjects above should apply for the interview.
- Upon selection/empanelment, the original documents, including eligibility qualification, DOB, caste, and age relaxation certificate, will be verified; if any discrepancy is found, the selection/empanelment shall stand cancelled.
